- Arrange rental and/or purchase of all associated lifting equipment in use by Metrol
- Conduct visual and certification inspections on lifting equipment and rental CCU's within Metrol
- Review and sign off pre-load out documentation.
- Support field operations team with any lifting & certification related enquiries.
- Co-ordinate with Facilities team to conduct annual & bi-annual inspections of all LOLER related storage & lifting equipment. (Cranes, forklifts, pallet trucks, slings, shackles, storage racks, etc..)
- Update lifting and certification procedures as and when required, including inspection sheets.
- Maintain a clean, safe and tidy workplace.
- Adhere to the set standards of personal safety in the workplace
- Perform any required duties in line with Metrol's QHSE policies
- Attend any relevant training courses as requested by management
